



# How to Access Funding

## OPENING THE SECOND CALL FOR PROPOSALS

The WTO Fisheries Funding Mechanism (commonly known as the WTO Fish Fund) opened its **second Call for Proposals on 2 February 2026** and will accept grant applications until **24 April 2026**.

### 1. What is the Fish Fund?

- The Fish Fund was established at the WTO in cooperation with the Food and Agricultural Organisation of the United Nations, the International Fund for Agricultural Development, and the World Bank, to assist developing and least-developed country (LDC) Members implement the WTO Agreement on Fisheries Subsidies.

### 2. How can the Fish Fund help WTO Members?

- The Fish Fund will provide developing and LDC Members that have ratified the [Agreement on Fisheries Subsidies](#) with grants to support technical assistance and capacity-building activities for the purpose of implementing the Agreement.
- Two categories of grants that will be offered:
  - > **Category 1** – Project Preparation Grants of up to USD 50'000 for activities such as studies, needs assessments, and preparation of larger projects.
  - > **Category 2** – Project Grants of up to USD 300'000 for more complex, programmatic interventions related to the implementation of the Agreement.

### 3. What is the deadline to submit a funding request?

- This second Call for Proposals is open until 24 April 2026.

### 4. Who is eligible to apply for funding?

- Only governments from developing and least developed WTO Members that have deposited their instruments of acceptance of the Agreement on Fisheries Subsidies with the WTO Director-General are eligible to submit funding requests.
- Requests should be made by national governments (ministries, agencies or public entities) responsible for implementing the project grants.

### 5. How to apply?

To apply for funding, please visit [www.wtofishfund.org](http://www.wtofishfund.org) and complete the application form. Applications must include the project's objectives and a description of proposed activities, and explain how the project aligns with the disciplines in the Agreement on Fisheries Subsidies and the [Fish Fund's Theory of Change](#).

- Grant applications must also include a detailed timeline with milestones, a work plan, a budget, and information on how the project will be implemented.

### 6. What happens after an application is submitted?

- After the Call for Proposals closes, the Steering Committee of the Fish Fund will review and evaluate all submissions. Selected applicants will be notified following the Committee's decisions.
